



Group Basic Life and Accidental Death and Dismemberment Insurance

Group Basic Life insurance from Standard Insurance Company helps provide financial protection by promising to pay a benefit in the event of an eligible member's covered death. Basic Accidental Death and Dismemberment (AD&D) insurance may provide an additional amount in the event of a covered death or dismemberment as a result of an accident.

The cost of this insurance is paid by Lemek LLC dba Panera Bread.

Eligibility

Definition of a Member	<p>You are a member if you are:</p> <ul style="list-style-type: none">• An active Associate or variable hourly-paid Baker employee of Lemek LLC dba Panera Bread who averages at least 30 hours a week based on the Employer's most recent measurement period, OR• An active L.L.C. Owner-Employee or employee Lemek LLC dba Panera Bread (other than an Associate or a variable hourly-paid Baker employee) and regularly working at least 30 hours each week. <p>You are not a member if you are a temporary or seasonal employee, a full-time member of the armed forces, a leased employee or an independent contractor.</p>
Class Definition	Class 2 - Bakers and Assistant Managers
Eligibility Waiting Period	You are eligible on the first of the month that follows or coincides with 60 consecutive days as a member.

Benefits

Basic Life Coverage Amount	Your Basic Life coverage amount is \$25,000.
Basic AD&D Coverage Amount	For a covered accidental loss of life, your Basic AD&D coverage amount is equal to your Basic Life coverage amount. For other covered losses, a percentage of this benefit will be payable.
Life Age Reductions	Basic Life and AD&D insurance coverage amount reduces to 65 percent at age 65 and to 50 percent at age 70.
